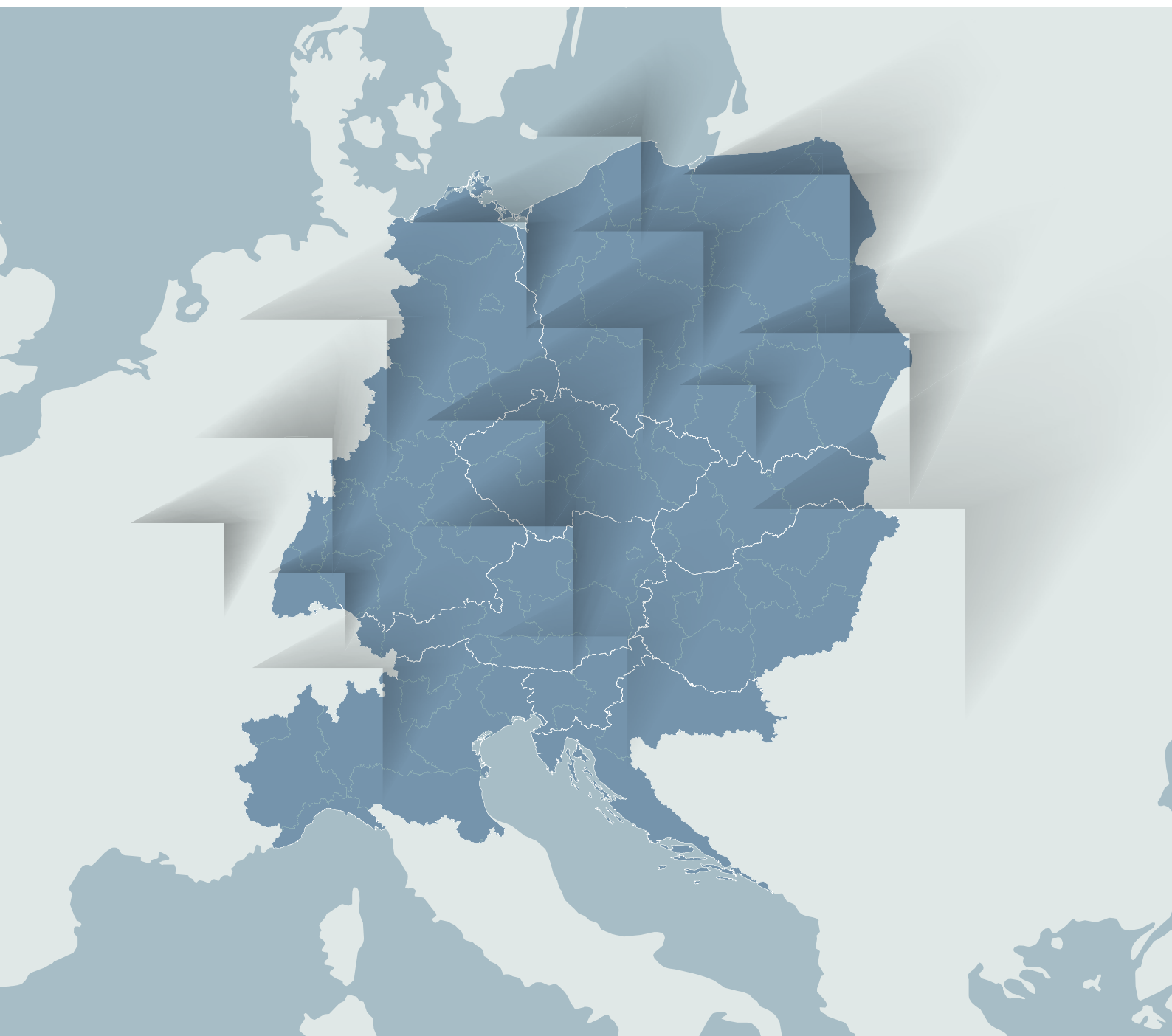


ANNOUNCEMENT OF THE THIRD CALL FOR PROPOSALS

21 September 2017



I. ANNOUNCEMENT

The Interreg CENTRAL EUROPE (CE) Programme invites public and private organisations in central European regions to submit applications to the third call for proposals. Detailed conditions and the timeline for the call can be found in the “Application manual - Third Call” included in the “Application package - Third Call”. The application package constitutes an integral part of this call announcement and is available at www.interreg-central.eu/apply.

2. OBJECTIVES

The Interreg CE Programme is funded by the European Regional Development Fund (ERDF) under the European Territorial Cooperation objective (ETC) of the EU Cohesion Policy, for the programming period 2014-2020.

The Interreg CE Programme supports regional cooperation among nine central European countries. The overall objective of the programme is “to cooperate beyond borders to make central European cities and regions better places to live and work” by implementing smart solutions answering to regional challenges in the fields of innovation, low-carbon economy, environment, culture and transport.

The programme runs from 2014 to 2020 and invests EUR 231 million to co-finance transnational cooperation projects promoted by public and private organisations from central European regions. Projects supported shall deliver concrete and visible outputs and results in response to well-identified challenges of the programme area and addressing development needs in an integrated manner. Projects focussing on purely academic cooperation or basic research or aiming at mere networking and exchanging of experience and/or not demonstrating the translation of outputs arising from “soft” actions (surveys, studies, etc.) into concrete and sustainable results will not be supported by the Interreg CE Programme.

The Interreg CE “Cooperation Programme” document in its latest version (Version 2.0) constitutes the legal basis for this call for proposals and is available at <http://interreg-central.eu/cooperation-programme>

3. PROGRAMME AREA

The CENTRAL EUROPE programme area includes all regions from Austria, Croatia, the Czech Republic, Hungary, Poland, Slovakia and Slovenia, as well as eight Länder from Germany (Baden-Württemberg, Bayern, Berlin, Brandenburg, Mecklenburg-Vorpommern, Sachsen, Sachsen-Anhalt and Thüringen) and nine regions from Italy (Emilia-Romagna, Friuli-Venezia Giulia, Liguria, Lombardia, Piemonte, Provincia Autonoma di Bolzano, Provincia Autonoma di Trento, Valle d’Aosta and Veneto).

4. THEMATIC FOCUS OF THE CALL

Within the third call, proposals can be submitted under all 4 priority axes, however certain programme specific objectives (SO) within the priority axes 1, 2 and 3 will be focused on pre-defined thematic topics. Furthermore, it is not possible to submit proposals under SO 2.3 “Improve capacities for mobility planning in functional urban areas to lower CO2 emissions”.

For a general description of contents of each priority axis and programme SO, including information on possible actions, beneficiaries and target groups, please refer to section 2 of the Interreg CE “Cooperation Programme” document in its latest version.

For specific information on the thematic focus of the call at the level of each SO, please refer to the tables in the following pages (3 to 5) as well as to Part A of the application manual for the third call. More information on the thematic scope

of each SO including examples of supported actions is provided in annex I of the manual. Annexes II and III present the programme intervention logic and types/examples of outputs.

Under the terms of this call, a project proposal must focus on only one priority axis and one SO.

Applicants are strongly encouraged to check the already approved projects in the respective thematic areas to avoid duplication and make use of synergies. 5. ERDF BUDGET AVAILABLE

The programme will allocate around 60m EUR ERDF to the third call for proposals. An indicative ERDF allocation to the four programme priority axes is presented in the following table. When deciding for project funding, such allocation may be adapted by the monitoring committee according to programme needs.

6. SUBMISSION OF APPLICATIONS

The third call for proposals of the Interreg CENTRAL EUROPE Programme is organised according to a one-step procedure. Project proposals must be submitted in English language and only through the web-based electronic monitoring system (eMS) on <https://ems.interreg-central.eu>. The application package for the third call contains also the off-line template of application form (for information purposes only).

7. ELIGIBLE APPLICANTS

In the framework of the Interreg CENTRAL EUROPE Programme, eligible applicants are:

- National, regional and local public bodies (including EGTCs in the meaning of Article 2(16) of Regulation (EU) No 1303/2013);
- Private institutions, including private companies, having legal personality;
- International organisations acting under the national law of any CENTRAL EUROPE Member State or, with restrictions, under international law²

It is to be noted that international organisations acting under national law of any country outside the CENTRAL EUROPE area are not eligible for funding by the Interreg CENTRAL EUROPE Programme.

8. PARTNERSHIP REQUIREMENTS

Projects supported by the Interreg CENTRAL EUROPE Programme must involve in the partnership:

- at least three financing partners,
- from at least three countries and
- being at least two of the partners located in CENTRAL EUROPE regions.

Applicants located outside the programme area but within the EU can also apply for funding as project partners. Please note that ERDF allocated to a single project for such partners, together with the ERDF spent outside the programme area, cannot exceed 20 % of the total ERDF contribution to such project. The involvement of partners from EU regions outside the programme area shall bring a clear benefit to the regions of the programme area. Their involvement is considered as exceptional and must be duly justified.

Applicants can also be located outside the EU, but they will not receive ERDF funding from the Interreg CENTRAL EUROPE Programme.

9. ELIGIBLE LEAD APPLICANTS

The following institutions can be lead applicants:

- National, regional and local public bodies (including EGTCs in the meaning of Article 2(16) of Regulation (EU) No 1303/2013);
- Private institutions, including private companies, having legal personality;
- International organisations acting under the national law of any CENTRAL EUROPE Member State.

² It is to be noted that international organisations acting under national law of any country outside the CENTRAL EUROPE area are not eligible for funding by the Interreg CENTRAL EUROPE Programme.

Only institutions located in the Interreg CENTRAL EUROPE Programme area (or meeting the requirements of “assimilated partners”³) can apply as lead applicants.

Private lead applicants have to comply with obligatory financial capacity requirements detailed in part D, chapter V.1 of the application manual.

Proposals submitted by private lead applicants not meeting the necessary financial capacity criteria will be rejected. Private lead applicants should therefore carefully check their ability to fulfil the applicable financial capacity criteria before submitting their proposal.

10. PROJECT SIZE

The recommended financial size of projects to be submitted in the framework of the third call for proposals is in the range of 1m to 5m EUR total cost. In exceptional cases, smaller or larger projects can be supported.

The size of the partnership should reflect the scope of the project and remain manageable. Therefore, the recommended maximum size of a partnership should not exceed 12 partners. Larger partnerships are possible but need to be duly justified according to the specific project scope.

11. CO-FINANCING RATES

The following co-financing rates apply:

- Up to 85 % for applicants of Croatia, the Czech Republic, Hungary, Poland, Slovakia, Slovenia;
- Up to 80 % for applicants of Austria, Germany, Italy;
- Up to 80 % for applicants located in EU regions outside the Interreg CENTRAL EUROPE Programme area.

In case of EGTCs covering geographical areas in which different co-financing rates apply, the co-financing rate applicable to the EGTC is the one of the country in which it is registered.

In case applicants intend to implement activities considered as State aid relevant, the maximum grant will be calculated applying the de minimis regime while respecting the co-financing percentages listed above. Should the activities to be carried out by EU-partners from outside the CENTRAL EUROPE area be considered as State aid relevant, the participation of these partners will not be allowed due to the impossibility for the programme monitoring committee to validate the result of the state aid assessment on behalf of a Member State not participating in the programme.

12. PROJECT DURATION

In the framework of the third call for proposals, the recommended project duration is from 24 to a maximum of 36 months, taking into account that **the latest possible end date for a project is 31 December 2021.**

13. AWARD CRITERIA

The selection of proposals is based on the assessment of received applications following a standardised procedure, which safeguards the principles of transparency and equal treatment.

Following a formal/administrative compliance check and - in case of private lead applicants - a lead applicant financial capacity check, each proposal passing these checks is assessed on its contents. The four strategic and operational assessment criteria against which eligible proposals are assessed are:

1. RELEVANCE
2. PARTNERSHIP
3. IMPLEMENTATION
4. BUDGET

Each criterion is composed of one or more sub-criteria, which are assessed according to scores from 1 to 5. The full list of assessment sub-criteria is available in part D, chapter V.1, point e) of the application manual for the third call.

PLEASE NOTE

Proposals not showing an adequate quality regarding the following two sub-criteria of criterion 1 “Relevance” will not be further assessed against other criteria and will be rejected:

- 1.1 - “Intervention logic and transnationality”
- 1.2 - “Policy and territorial relevance”

Decisions on project selection will be taken by the monitoring committee of the Interreg CENTRAL EUROPE Programme at the level of each priority axis, on the basis of the results of the assessment.

14. DEADLINE FOR SUBMISSION

Project proposals must be submitted by the lead applicant through the eMS at the latest by **Thursday, 25 January 2018 at 18:00 CET**.
